**[PROPOSED] ORDER GRANTING PLAINTIFF'S UNOPPOSED
MOTION FOR ADMINISTRATIVE ORDER**

WHEREAS, the parties in the above-captioned action agreed to a Settlement¹ reflected in the Stipulation and Agreement of Settlement, Compromise, and Release, dated June 4, 2025 (Trans. ID 76394398) (the "Stipulation");

WHEREAS, the Court entered a Final Order and Judgment approving the Settlement reflected by the Stipulation on October 8, 2025 (Trans. ID 77265596);

WHEREAS, Plaintiff has filed an Unopposed Motion for Administrative Order ("Motion"), seeking: (1) authorization for A.B. Data (the Settlement

Administrator) to make the Initial Distribution of the Net Settlement Fund to Eligible Class Members; and (2) approval of payment from the Settlement Fund to the Settlement Administrator for Notice and Administration Costs;

WHEREAS, in support of Plaintiff's Motion, Plaintiff filed the Affidavit of Jack Ewashko in Support of Plaintiff's Unopposed Motion for Administrative Order ("Ewashko Affidavit"), describing: (1) the specific steps the Settlement Administrator plans to take in order to effect distribution of the Net Settlement Fund in the manner provided in the Stipulation, and (2) the Notice and Administration Costs that A.B. Data has incurred and will incur in providing notice to the Class and administering the Settlement;

IT IS HEREBY ORDERED, this __ day of _____ 2026, that Plaintiff's Motion is GRANTED; and

1. The Settlement Administrator is directed to arrange for the distribution of the Net Settlement Fund to Eligible Class Members in the manner contemplated by the Stipulation and further described in the Ewashko Affidavit.

2. A final payment of approximately \$26,329.41 from the Settlement Fund to A.B. Data for Notice and Administration Costs incurred in connection with administering the Settlement is hereby authorized.
